

## The Financial Implications of Buying 20 Pendower House, Roseland Parc, Tregony, Truro, Cornwall, TR2 5NH

Set out below are worked examples of the financial implications of buying the above property. Created on 08/04/2026.

**Note: These worked examples are for guidance only. Please discuss your individual circumstances and financial commitments with your solicitor, other legal or financial adviser.**

This illustration is not a forecast and, like any other investment, the value of properties in the village could go down as well as up.

### EXAMPLE 1: TYPICAL ANNUAL COSTS

This first example focuses on the annual costs associated with purchasing a retirement property. **It excludes:**

- The cost of any **mortgage** you may have, and
- The personal monthly bills for which you would be liable, such as council tax, electricity, gas, water, telephone rates and charges (if applicable), contents insurance, television licence, broadband/satellite/cable subscriptions and any other bills.

The costs shown are based upon the purchase cost and service charge costs for single or double occupancy of a 2 bedroom Apartment, 20 Pendower House, Roseland Parc, Tregony, Truro, Cornwall, TR2 5NH, purchased for **£380,000.00 Three Hundred and Eighty Thousand Pounds**.

As a leasehold owner, you will be responsible for the following costs, which apply from: 01/04/2026 to 31/03/2027 and annually thereafter.

### EXAMPLE 2: A SALE (Otherwise known as assignment) of your property.

This second example deals with some of the one-off costs if you were to sell (otherwise known as to assign) your property. **It excludes:**

- Any outstanding **ground rent or service charge** that you owe;
- Any **mortgage costs**, including the cost of paying off (sometimes referred to as redeeming) your mortgage;
- The costs of any **solicitor**, conveyancer or legal advisor you appoint to deal with the sale/assignment;
- Any **estate agent fees**; (1.5% when Roseland Parc Ltd undertake sales and marketing or sellers choice of agent)
- Any **tax** which you may have to pay, including stamp duty;
- Any **costs of moving**;
- The **cost of ensuring the property is in good decorative order prior to the resale**.

***The assignment fee, which is payable to the landlord, Roseland Parc Ltd, provides a return on the original investment in developing the communal facilities in the Village. It does not contribute towards the costs of any services that are provided or to a sinking fund and accordingly is not held in trust for its residents.***

If you purchase the property for **£380,000.00** and in the future sell/assign it for the sale prices below, examples of the corresponding assignment fees incurred on the sale/assignment of the property are indicated underneath the sale prices:-

**The proportion of the sales price payable changes: it is 5% (1st year), 10% (2nd year) or 12.5% (after year 2) of the sales price when re-sold.**

Example H: If you sell the property within 2 years and the property has decreased in value by 3.0% per annum.

The Assignment Fee if paid on sale	10.0%	of the sale price	£35,754.20	Payable when you sell

Example I: If you sell the property within 1 year and the property has increased in value by 3.0% per annum.
